I, Craig A. Sorensen, am a Construction Consultant. My consulting practice includes project planning, scheduling, cost analysis, and schedule delay impact analysis on private and government construction contracts.

I have been qualified as an expert in Court on Public Works bidding practices, and on Public and Private Projects on construction management, critical path method schedule analysis, schedule delay and related damage calculations, productivity and disruption damages, reasonable value of the work, and custom and practice concerning CPM scheduling, delay analysis, change order requests, change orders, methods of measuring inefficiency, and documenting delay claims.

I was an instructor for the Department of Engineering, Information Systems and Technical Management at the University of California, Los Angeles, Continuing Education Program from 1995 to 2002. I taught UCLA's Planning and Management Systems (CPM) class for the Professional Designation in Construction Management, a certified program. I continue to be a frequent speaker at Engineering and Construction Association meetings and conferences, as well as academically for Loyola School of Law, University of California, University of Southern California, California State University, and Lorman Educational Services.
